The license is issued by Directorate General of Central Business Registry & Intellectual property (ACBR-IP) MOIC in accordance with and subject to the effective law of Afghanistan.

All businesses must submit their Business Declaration Form(S) according to the law to the Revenue Department of the Ministry of Finance and Directorate General of ACSR-IP Individuals and companies who do not submit their declarations within

the given timeline, will be penalized in accordance with the Income Tax Law of the Islamic Republic of Afghanistan.

All businesses must abide by effective rules and regulation of the Islamic Republic of Afghanistan in their commercial activities.

Based on their national obligation and services to the nation, businesses are obliged to import high quality materials and products and should avoid import of low quality goods.

All businesses must formally notify the ACBR-IP prior to any changes being brought to the company structure, shares, and address and should follow the legal procedures

This office reserves the right not to renew your business license for justified reasons. In no event shall Diagnose & Control or its representatives be liable for having to have the changes registered accordingly.
